Dear Cindy:

Please find enclosed three (3) originals of Supplement No. 2 to the Fire Protection Services Agreement between Washington State Ferries (WSF) and North Kitsap Fire & Rescue covering WSF's Kingston Ferry Terminal.

The enclosed Supplement extends the term of the Agreement for five (5) additional calendar years, retroactive to January 1, 2016. The fire protection service fee remains \$8,324.20 total per year and \$41,621.00 total for all five (5) years, as shown on Exhibit A to the Agreement.

The Supplement has already been signed by both parties via e-mail exchange. The enclosed originals are a follow-up process. The originals have been signed on behalf of WSF, so please sign all three originals, keep one for your file and return two to my attention at the above address.

FIRE PROTECTION AGREEMENT NO. GCA 5143**

SUPPLEMENT NO. 2

ORIGINAL

This Supplemental Agreement is made and entered into this 2nd day of August, 2016, between the **WASHINGTON STATE DEPARTMENT OF FERRIES DIVISION**, operating as Washington State Ferries ("**WSF**"), and **KITSAP FIRE & RESCUE ("NKFR")**.

WHEREAS, **NKFR** is organized and equipped to provide fire protection services within and in the vicinity of its boundaries, and **WSF** desires that **NKFR** provide such services to its property located within those boundaries; and

WHEREAS, the parties previously entered into the Kingston Ferry Terminal Fire Protection Agreement No. GCA 5143, dated February 22, 2008; and;

WHEREAS, the parties previously entered into Agreement Amendment No.1, dated August 17, 2011 extending the Term of the Agreement for an additional five (5) years; and the parties wish to further extend the Term per the authorization in the Agreement;

NOW THEREFORE, in consideration of the terms, conditions, covenants and performance contained herein, the parties agree as follows:

1. **Term.** Pursuant to the authorization in Section 4 of the original Agreement, the Term of the Agreement shall be extended for an additional term of five (5) years. The Agreement extension shall be retroactively effective January 1, 2016 and expire on December 31, 2020.
2. **Fire Protection Service Fee.** In consideration for receiving fire protection services, during the extension Term specified in Paragraph 1 above, **WSF** shall pay to **NKFR** an annual fire protection service fee equal to the amount provided in the original Agreement, as itemized on Exhibit A attached hereto. The attached Exhibit A has been updated solely to reflect the extension Term.

3. **Other Provisions.** Except as expressly modified herein, all other terms and conditions of the Agreement, as amended, shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto, by their duly authorized representatives, have executed this Supplemental Agreement as of the day and year first written above.




